(Re)Mapping Mobility: Migration, Thresholds, and the Politics of (Dis)Placement

In an era of political polarisation, economic instability, and shifting geopolitical landscapes, the experience of migration is increasingly marked by liminality. Many who migrate find themselves 'inbetween' – neither fully embedded in their new environments nor entirely tethered to those they left behind. From bureaucratic delays that extend legal limbo to affective and psychological states of being stuck, the thresholds of migration have become sites of tension, negotiation, and contestation.

This conference explores contemporary experiences of (voluntary and forced) mobility with a focus on those navigating precarious and transitional spaces – those waiting, being pushed, or living in prolonged uncertainty. How do states, institutions, communities, and migrants themselves manage these states of flux? How does mobility intersect with governance, global inequalities, and shifting cultural frameworks? And how are ideas of 'home' and 'arrival' disrupted by enduring impermanence?

Bringing together scholars, practitioners, and creative contributors from diverse disciplines, the conference fosters conversation on how people live through and respond to these conditions. It invites reflection on the systems that shape mobility and displacement, as well as the everyday strategies of endurance, refusal, and adaptation that emerge in their wake. From survival and solidarity to critiques of containment, the programme speaks to the complex realities of navigating, and resisting, the thresholds of migration.
